

**Explanation**

Established in 1994, Chattahoochee Riverkeeper (CRK, formerly Upper Chattahoochee Riverkeeper) is a non-profit, environmental advocacy organization with 7,300 members dedicated solely to protecting the Chattahoochee River, its tributaries and lakes. We are a member of the Waterkeeper Alliance, an international coalition of 200-plus waterkeepers. CRK's mission is to advocate and secure the protection and stewardship of the Chattahoochee River, its tributaries and watershed, in order to restore and conserve their ecological health for the people and wildlife that depend on the river system. CRK accomplishes its goals by using advocacy, education, research, communication, cooperation, monitoring and legal actions. Our work traditionally has fallen into four areas: community outreach and stewardship, policy and regulatory initiatives, water monitoring, and legal action. We are guided by a board of directors and an advisory board composed of individuals with diverse backgrounds in law, engineering, science, finance, industry, recreation, media, graphic arts and fundraising. In 2013, CRK received numerous accolades for its organizational management and program successes. For the seventh consecutive year, CRK maintained a 4-star rating from Charity Navigator (CN), America's largest independent charity evaluator, the highest rating given for financial health and accountability and transparency. According to CN, only 2% of the 5,400 charities evaluated have received at least seven consecutive 4-star evaluations. In addition, CRK was selected as one of ten medium-sized charities worth watching. For its program work, CRK was selected as Georgia Project WET Organization of the Year with partner Elachee Nature Science Center for CRK's collaborative success of Georgia's only floating classroom. Over 4,500 students were educated onboard our floating classroom including 960 underserved youth who received scholarships. In addition, CRK was named the number one Adopt-A-Stream group in Georgia for the fourth consecutive year for most volunteer water samples collected. CRK's community outreach and stewardship programs reached more people than ever before adding 1,369 new members to the organization. CRK held 46 conservation workshops, provided 1,452 rain barrels and reached more than 2,000 people with the tools and knowledge to adopt water conservation and efficiency practices at home and in their businesses. An additional 870 citizens, officials, students and business leaders were provided an updated Tapped Out presentation and No Time To Waste materials, both of which are part of the organization's larger water conservation program. CRK hosted multiple river awareness events including a Film Festival, River Race and Festival, Patron Dinner, Member Celebration, outings and other events where over 3,500 people attended. We engaged 1,280 volunteers from community organizations and corporations in stream, lake and river cleanups, including 553 people in the 3rd Annual Sweep the Hooch multi-site cleanup for a total of 14 tons of trash removed from waterways and 1.4 tons of trash recycled. In addition, CRK organized and led twelve outings including paddle and boat trips, hikes and facility tours. CRK staff trained and manages sixteen student interns.

**Explanation**

CRK's policy and regulatory programs are directed at local, state, regional and federal elected officials, bureaucrats, and other decision-makers on various policies, rules and laws affecting water quality and water quantity. In 2013, CRK spent 1,200 hours reviewing and providing comment on technical hydrologic models and participating in the governance of the Apalachicola-Chattahoochee-Flint Stakeholders Group (ACF Stakeholders) to resolve the decades-long tri-state water conflict. CRK also testified in eight public hearings and submitted eight comment letters on various water issues including stormwater, buffer legislation, federal permitting and resource management. In addition, CRK is a leading organization of the Georgia Water Coalition, which this year stopped a bill that would have significantly changed Georgia water law to allow the state to control augmented flows and weaken our long-standing regulated riparian water rights legal system (SB 213). CRK's water monitoring programs have grown exponentially in the past five years with more samples taken, processed and analyzed than ever before. In 2013, 1,482 water samples were taken by two dozen volunteers at 45 urban stream locations as part of our Neighborhood Water Watch Program. In addition, we completed four years of nutrient monitoring at ten locations on Lake Lanier, collecting 91 samples annually, and we provided the data to the state and others to support a lake cleanup plan. We also completed a full year of water quality monitoring at five locations in Snake Creek, a tributary to the Chattahoochee in Carroll County and produced a stream assessment report. We also trained 71 volunteers during five Adopt-a-Stream workshops and another 60 volunteers were trained in three Get the Dirt Out workshops. CRK employs many tools to obtain compliance with local, state, and federal rules and laws and to stop pollution from reaching the Chattahoochee River and its tributaries and lakes. In 2013, CRK launched the Protecting Streams and Communities from Industrial Pollution program bringing 24 industrial facilities (auto salvage yards, food processing plants, concrete and steel pipe manufacturers, railroads, and paving, recycling and oil companies) into compliance with the industrial stormwater general permit and reducing the amount of oil and grease, zinc, lead, sediment and other pollutants that flow into the waterways. We also identified and stopped two major sewage spills in Atlanta's Tanyard Creek which flows through a city park and responded to 190 Citizen Hotline calls handled that resulted in 71 field investigations and 14 enforcement actions taken.
