In 2020, the largest program area was water monitoring, which encompasses our urban stream monitoring as well as river and lake water quality testing. Through our Neighborhood Water Watch program we tested 12,882 water samples. We also collected and processed 62 lake samples for nutrient levels, and 150 river samples for bacteria pollution in the Chattahoochee River National Recreation Area. CRK also monitors compliance with stormwater rules at various industrial facilities. In 2020, we investigated 96 industrial facilities using a custom developed mapping program. In addition, we developed a low cost, remote water quality monitor system that relays data in real time. We deployed three of these devices in urban and rural streams. We also answered and responded to 243 Hotline calls from the public and conducted 55 site investigations.

4b (Code:) (Expenses \$ 792,039. including grants of \$) (Revenue \$)

In 2020, the second largest program area was community outreach and stewardship projects, which includes our trash cleanups, rain barrel workshops, and virtual gatherings. Many programs were impacted in one form or another due to the pandemic. However, we pivoted many engagements to virtual opportunities. We mobilized 1,146 volunteers to remove 30 tons of trash and tires from the watershed, and recycled an additional 10 tons. Additionally, we distributed 362 rain barrels. We delivered 60 virtual training and webinars for hundreds of viewers. And trained 28 interns in development, water quality testing, and law.

In 2020, the third largest program area was our advocacy work. We wrote and delivered 36 public comment letters and testimonies to agencies and the general assembly to protect environmental resources. We settled one legal case resulting in the cleanup of an industrial site along a creek in metro Atlanta as well as directed \$60,000 in settlement fees to projects to benefit the Chattahoochee watershed.
