IN 2023, THE LARGEST PROGRAM AREA WAS WATER MONITORING, WHICH ENCOMPASSES OUR URBAN STREAM MONITORING AS WELL AS RIVER AND LAKE WATER QUALITY TESTING. THROUGH OUR NEIGHBORHOOD WATER WATCH PROGRAM WE COLLECTED AND TESTED 5,559 WATER SAMPLES. WE FOUND AND STOPPED 15 SEWER SPILLS AND IDENTIFIED 1 MAJOR WATER TREATMENT PLANT FAILURE. WE ALSO COLLECTED AND PROCESSED 147 RIVER SAMPLES FOR BACTERIA POLLUTION AND 18 SAMPLES FOR MICROPLASTICS. IN THE CHATTAHOOCHEE RIVER NATIONAL RECREATION AREA.
